**The Constitution of Sierra Leone (Amendment) Act, 2008.** Short title.

**Being an Act to amend the Constitution of Sierra Leone, 1991 so as to grant to the Anti-Corruption Commission the power to prosecute offences involving corruption.**

*[31st July, 2008.]* Date of commencement.

ENACTED by the President and Members of Parliament in this present Parliament assembled.

of 1991.

**1.** The Constitution of Sierra Leone, 1991 is amended by the repeal and replacement of subsection (3) of section 64 thereof by the following subsection:—

“(3) All offences prosecuted in the name of the Republic of Sierra Leone except offences involving corruption under the Anti-Corruption Act, 2000, shall be at the suit of the Attorney-General and Minister of Justice or some other person authorized by him in accordance with any law governing the same”.

**2.** The Constitution of Sierra Leone, 1991 is amended by the repeal and replacement of paragraph (a) of subsection (4) of section 66 thereof by the following paragraph:—

“(a) to institute and undertake criminal proceedings against any person before any court in respect of any offence against the laws of Sierra Leone except any offence involving corruption under the Anti-Corruption Act, 2000”.
