**LAW modifying the Constitution of the Turkish Republic.—
February 5, 1937⁽¹⁾ (as amended by Law No. 3272 of
November 29, 1937⁽²⁾)**

No. 3115

(Translation)

ART. 1. Articles 2, 48, 74 and 75 of the constitutional law⁽³⁾ have been modified as below :

“ 2. The Turkish State is republican, nationalist, democratic, State-controlled, laic and revolutionary. Its official language is Turkish. Its capital is the city of Angora.

48. The form of organisation of the Ministries is to be governed by a special law.

74. No one may be expropriated of his movable or immovable property, unless it has been regularly shown to be necessary in the public interest, and unless the equivalent value has been paid in advance in accordance with the relevant law.

The compensation to be paid for the expropriation of lands and forests that are to be expropriated in order to make the tiller of the soil an owner of land, and to bring forests under State administration, and the method of payment of such compensation, shall be regulated by special laws.

No one may be forced to make sacrifices other than such liabilities in money, kind or labour as may be imposed by law in extraordinary circumstances.

75. No one may be censured on account of the philosophy he professes, or on account of his religion or religious denomination. All religious services may be freely held provided they are not contrary to public order, public morality and the laws.”

2. This law comes into force as from the date of its publication.
